II. DISCUSSION/INFORMATION AGENDA

- A. 2020-2021 Independent Audit Report and Corrective Action
 - Samantha Moore from Eide Bailly, LLP presented the Independent Auditor's Report, Corrective Action and
 required communications letter. The Audit results reported that the District had no material weaknesses or
 significant deficiencies and was in compliance in all areas. The District was granted an official opinion of
 Unmodified. Compliments were given to Jaime Towe and staff for their support throughout the audit.
- B. Elementary and Middle School Counselor's Report
 - 1. School Counselors Katrina Broussard, Erika Rodriquez, Taylor Dell'Aringa, Eric Domen, Star Graves, Amanda Albritton introduced themselves and presented information regarding counseling services and the focus at each site. They explained the three domains of providing counseling through Academic Development, Social/Emotional Development and College/Career Development. Eric Domen began the presentation with a Mindfulness exercise. They also provided the Board with data on how many students are seen in individual, small group, or classroom sessions. Linda Brughelli noted that the work they do and as a team is essential.
