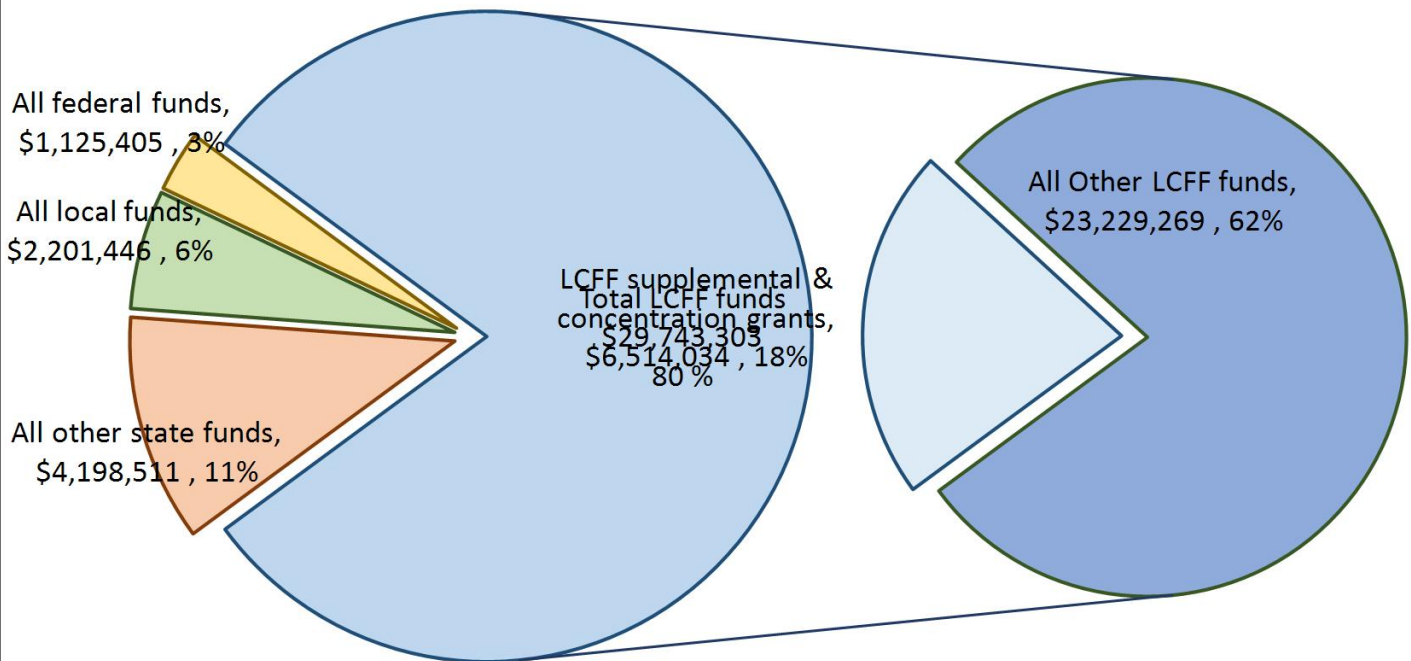

### Projected Revenue by Fund Source

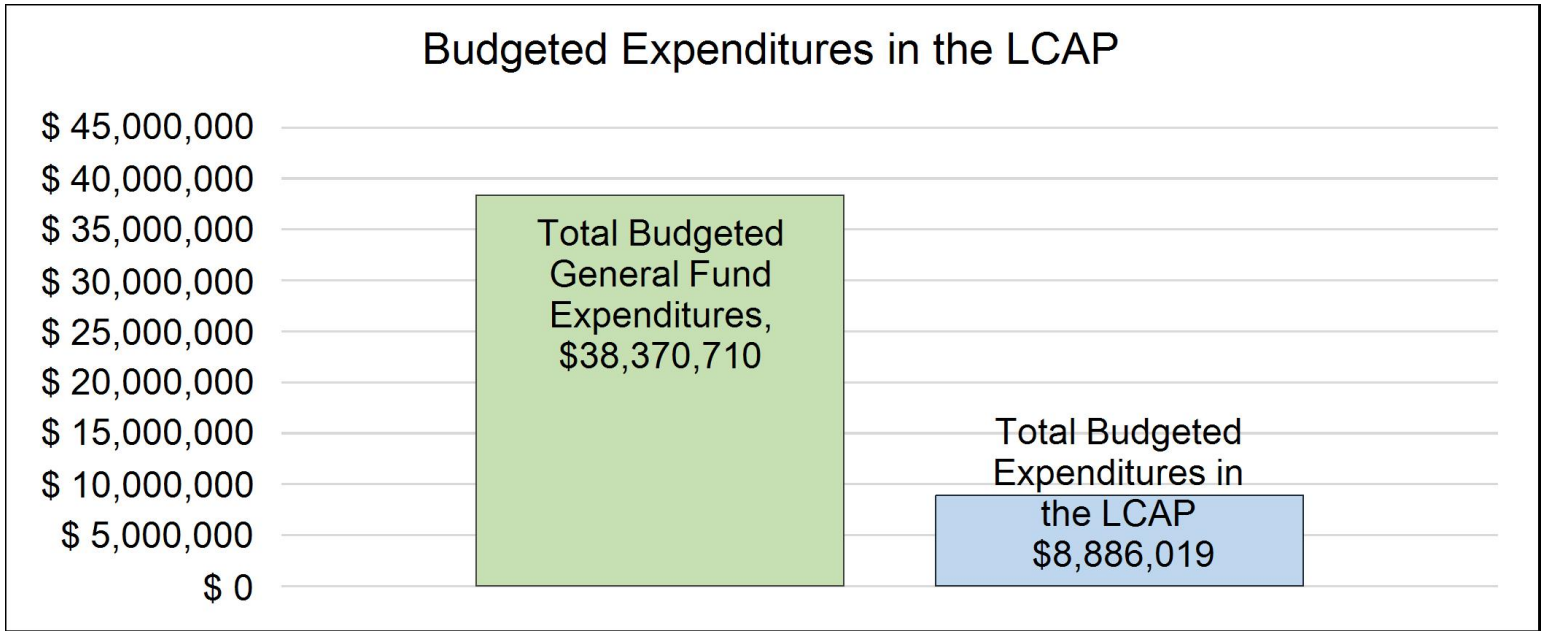


This chart shows the total general purpose revenue Salida Union School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Salida Union School District is \$37,268,665, of which \$29,743,303 is Local Control Funding Formula (LCFF), \$4,198,511 is other state funds, \$2,201,446 is local funds, and \$1,125,405 is federal funds. Of the \$29,743,303 in LCFF Funds, \$6,514,034 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

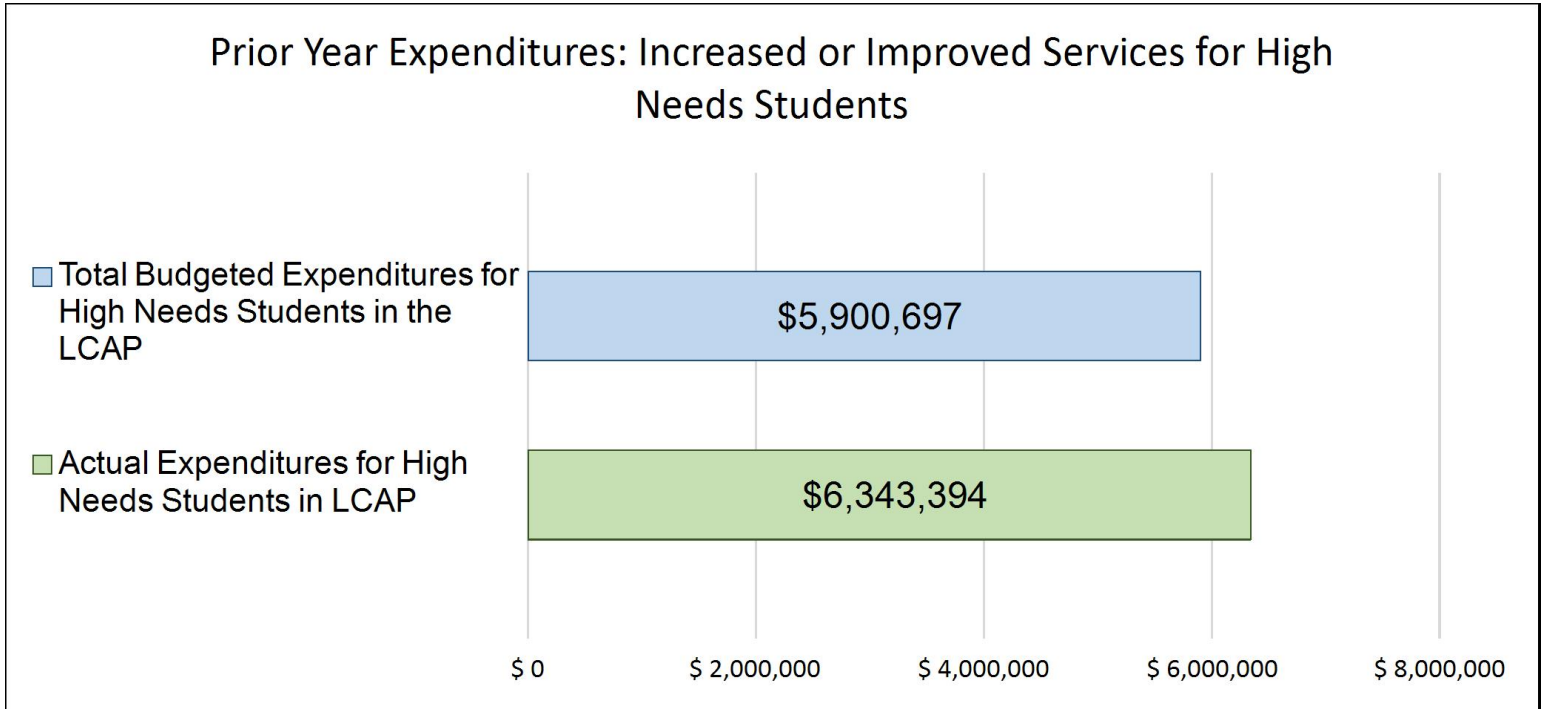

## Plan Summary [2023-24]

### General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Salida Union School District serves the northern portion of Stanislaus County, north and adjacent to the city of Modesto, California. Salida is an unincorporated community. Salida Union School District, a K -8 district, serves 2169 students (2022/2023 CBEDS Information Day data), including 68.34% Hispanic, 15.58% White, and 1.84% African American. Approximately 30.66% are English Learners (ELs). Approximately 202 students are classified as students with disabilities (SWDs), 9.31% of district enrollment. Approximately 1724 students are unduplicated bringing the percentage to 79.73% of the student enrollment.

The district continues to see a trend of declining enrollment. Since the 2017/2018 school year, the district has seen a loss of 222 students, a drop in enrollment of 9.28%. In addition, the number of students who are socio-economically disadvantaged has increased by approximately 1.82%. Special Education students are serviced within the district (Speech, Resource, and LH and SH inclusion Special Day classes) and also as a part of our Stanislaus County SELPA (ED, DHH, PH, SH, and Autism Special Day classes).

### Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

The district has seen great success in responding to the needs of students by continuing a dedicated focus on early literacy in K-2, mathematics K-8 and strengthening school climate and PBIS structures at all schools. District local assessments in reading have shown very positive gains in student's reading performance in grades K-3. Core instruction was strengthened with Heggertys' explicit phonemic awareness curriculum and K-2 - new Benchmark phonics materials authored by Wiley Blevins based on the science of reading to replace old Benchmark materials from 2016. Professional learning focused on high-quality core instruction supported by universally designed lessons to

ensure students' access to grade level content and opportunities to accelerate their learning.

#### Early Literacy benchmark assessment results:

- Kindergarten showed 95.6% of students reading in grade level text.
- First grade showed 82.4% of students reading in grade level texts.
- Second grade showed 68% of students reading in grade level texts.

#### 3rd Grade Reading:

- Benchmark assessment results show 57.1% of 3rd grade students are reading at grade level when assessed using a 1 to 1 authentic reading assessment (end of Trimester II).
- iReady Diagnostic II showed 53% of students reading Early-on or Above grade level which was a 29% increase from the 2021-22 school year.

Parent surveys continue to reflect a high level of confidence in the district with 93% of parents agreeing that the district continues to create a welcoming environment and 96% of parents agreeing that schools have a positive school climate and promote school connectedness. All elementary schools continue to show a suspension rate of Very Low or Low.

Another hallmark of Salida Union School District's educational experience is the opportunities provided to children for The Arts. The district convened an Arts Planning team of over 25 members to set the course for the next five years in arts education. The team included administrators, general education teachers, arts teachers, parents, and local community arts leaders. The district recognizes the value of creative health as part of a well-rounded education. The vision is to provide on-going engagement where students personally experience the breadth of all arts disciplines and honor cultural diversity as well as support students' emotional well-being.

- 100% of K - 5 students have an art and music class.
- 100% of middle school students have access to an Arts class.

#### Elementary Access to the Arts:

- Orff Music (K - 5th grades)
- Drum Circles (4th and 5th grades)
- Instrumental Opt-In (5th grade)
- Mistlin Art Classes - 10 times per year - (K-5th grades)

#### Middle School Access to the Arts:

- Beginning Band, Advance Bands, Strings/Orchestra, Clubs
- Mistlin Art Classes - 6 times per year - (7th & 8th grades)

The district surveyed parents and interviewed middle school students about The Arts. 93% of guardians say it is extremely important to learn about the arts in school. One parents said, "My son loves art and feels more motivated about school if he has the opportunity to express

himself". One student shared, "Art and music are important to me. There was a time when I was struggling and I listened to music. The words in the song were like how I was feeling. The music helped me." Another student shared, "Arts classes are a stress reliever. Like, you feel better after having it."

## Reflections: Identified Need

Low - African Americans, English Learners, Hispanic, Homeless, Socioeconomically Disadvantaged, Two or More Races, White

Until the Fall 2022 CA Dashboard, Salida Union School District had never entered into Differentiated Assistance (DA). The district was identified based on two subgroups - Students with Disabilities and Two or More Races. The district has always worked in close partnership with Stanislaus COE. Our continued partnership will help to evaluate the effectiveness of programs and strategies to make adjustments as needed to continue to improve student outcomes.

District - Students with Disabilities (Chronic Absenteeism & Academics)

- Chronic Absenteeism (Very High) 44.7%; 136/304 students
- English Language Arts (Very Low) 123.7 points below standard; 195 students
- Mathematics (Very Low) 159 points below standard; 191 students

#### District - Two or More Races (Chronic Absenteeism & Suspension)

- Chronic Absenteeism (Very High) 35.5%; 49/138 students
- Suspension (Very High) 6.3%; 9/142 students

Further review of the Dashboard shows that the district does not have any state indicator for which the performance of any student group was two or more performance levels below the "all student" performance level. It is clear that the pandemic has affected all subgroups of students as seen across the county, state and nation. According to Stanford News (2022 Oct 28) the "pandemic exacerbated educational inequalities based on income, showing the most pronounced learning losses among students in low-income communities and school districts." The comparative data in Salida USD between All Students and Socioeconomically Disadvantaged (SED) students shows both groups in the same placement level across Engagement, Climate and Academic Indicators.

#### Engagement and Climate:

As with many districts in California, Chronic Absenteeism shows as Very High (34.2% chronically absent; 810 students). Attendance numbers have improved this year, but they haven't returned to pre-pandemic levels for the district. Some families have struggled to rebuild the habits necessary to help their children attend school every day. Some families still fear their child will contract COVID-19 in the classroom. Things are slowly improving as the district helps communicate the importance of daily attendance and how frequent absences can have an impact on their child's success in school. District local data shows chronic absenteeism as 26.33% chronically absent; 592 students chronically absent. (March 6, 2023)

The District Suspension Rate shows as High (4.4%; 107 students suspended once). The middle school suspension rate of 11.8% (99 students) contributed significantly. During the 2021-22 school year, the middle school master schedule followed a cohort model with students having in-person classes every other day on a block schedule to cohort groups of students. There was an increase in classroom disruptions from student misconduct at the middle school. This year, the middle school has returned to single periods with all subjects taught each day and is seeing a reduced suspension rate when looking at local data. District local data shows a change in the district suspension rate 2.04% students suspended at least once; 47 students suspended at least once (43 middle school; 4 elementary) (March 6, 2023) Currently, the middle school has reduced the suspension rate Middle School suspension rate is 5.52%; 43 students suspended at last once. (March 6, 2023)

#### Academics:

The district showed as Low (30.1 points below standard) in English Language Arts and Low (68.5 points below standard) in Mathematics. In November 2022, California measured 2018–19 versus 2021–22

The district is keeping a close eye on current 3rd and 4th grade students who as a result of the pandemic were impacted in the earliest grades. Teacher professional learning focused on universally designing lessons, the major work of the grade and formative assessments to make strategic instructional decisions.

Additional Targeted Support and Intervention (ATSI) - 4 of 5 schools were identified. Elementary Schools for 1 subgroup - Students with



Disabilities. The middle school for 3 subgroups: Students with Disabilities, Socioeconomically Disadvantaged and Two or More Races.

# Engaging Educational Partners

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

The district provides opportunities for educational partners to engage meaningfully in the development, improvement, annual update and revision of the LCAP. District educational partners who participate in the development of the LCAP include: parents, students, teachers, principals, administrators, other school personnel, board members, District English Language Advisory Committee, District Curriculum and Technology Committee, LCAP Advisory Committee and local bargaining units of the LEA. The annual district timeline is: 1) Implement LCAP Goals, Actions, Programs and Services (August – September); 2) Monitor and assess LCAP implementation (October – December); 3) Identify additional needs/changes based on LCAP monitoring (January – March) and 4) Review draft of proposed changes and provide a public hearing prior to board approval (April – June). Through a Plan-Do-Study-Act (PDSA) cycle of continuous improvement the district involves, updates and consults with educational partners in a variety of ways including: student, parent, staff surveys; committee meetings; discussion forums; posting information related to LCAP on the district website; mass phone calls/emails/text messages to families inviting them to participate in discussions and provide feedback.

Through the use of the Parent and Family Engagement reflection tool, the LCAP Advisory committee discussed and provided feedback to the district on: Building Relationships between School Staff and Families, Building Partnerships for Student Outcomes, and Seeking Input for Decisions. All district educational partners engaged in discussions to review current district Goals, Actions, Programs and Services and make recommendations to maintain, modify, monitor, expand or discontinue.

Through the District English Language Advisory Committee (DELAC), the committee discussed and provided feedback to the district on: Building Relationships between School Staff and Families, Providing Families Information and Resources to Support Learning in the Home, At-Risk and Long Term English Learners (LTELs) and interventions the district provides to English learner students, and providing opportunities for families to learn English.

The district consulted with the local SELPA regarding Goals and Actions for the 2023-24 school year. Actions, programs and services were discussed to support and improve student outcomes for Students with Disabilities (SWD). Baseline CA Dashboard data shows SWD Chronic Absenteeism (44.7%; Very High), Suspension (5%; High) English Language Arts (Very Low; -123.7) and Mathematics (Very Low; -159) The district's goal is to build a culture of inclusion with attention to the variability of learning needs. Actions for students with disabilities were highlighted in the LCAP. (Actions 1.2, 2.1 and 2.2)

A summary of the feedback provided by specific educational partners.

District educational partners provided feedback that the district's three goals should remain with no changes to the wording. Items to maintain included: retention of high quality staff; school counselors; elementary PE staff; Wednesday minimum day release for PLC time; Learning Support Teams to help provide push-in support in reading; Wednesday STEAM activities for elementary students including artists; music program; online software - Footsteps2Brilliance, iReady, and ZEARN mathematics; and release time for professional learning by grade levels or departments.

The District LCAP advisory committee feedback prioritized three areas of continued focus:

- 1) Providing families with information and resources to support student learning at home. Ideas generated included: Continuing Math Family Nights, The Toolbox - 12 Tools trainings provided by counselors.
- 2) Creating Welcoming Environments and Building Trusting Relationships. Ideas included: Continue strong teacher/parent relationships - welcoming communication school to home; Greeting students (Principals, administrators) out front everyday; and a Welcoming Office Staff.
- 3) Two-way communication. Ideas generated included: Continue Aeries; Parent Square -Text, Email notifications; Translated Information for parents; Positive First Contacts from school office staff.

The District English Language Advisory Committee (DELAC) gave input during two district meetings with the Superintendent in attendance. (February and April) Conversations and feedback focused on: what can the district do to improve, Imagine Language & Literacy software for intervention, small group instruction in reading, additional para support, iReady reading & mathematics, English learner data from the CA Dashboard, and Long Term English Learners. Parents also provided input to information and family nights they would like to see.

On April 17, 2023 the proposed Overview of the Salida LCAP was posted on the district website. In addition, a place for public comment was opened for comments. <http://www.salida.k12.ca.us>. The Superintendent has not received any questions, comments or input regarding LCAP additions, deletions or changes to programs, actions or services. Therefore, there has been nothing to respond to in writing.

The material differences between the 2022-2023 budgets and estimated actuals in Action 2 of Goal 2 was that there were unused or remaining balances from budgets planned for expenses such as attendances incentives, music supplies, student gardens, and book replacements and replenishments for school libraries. The materials difference for Action 3 of Goal 2 was that we decided after the adoption and approval of our LCAP to add an HVAC project. This project reflects a significant increase in our projected expenditures when compared to budget.

Successes:

- The district continued to begin the school year with Back to School Family event. Salida families appreciate this approach before the school year begins. These family meetings ensure a personalized approach to engage families in meaningful communication and begin the school year on a positive note.
- The district continues strong, two-way communication through the use of ParentSquare, a safe and secure platform for all school-to-home communication. 98% of families are enrolled to use ParentSquare communication. Parents receive all school, classroom and group communication via email, text or app notification.
- Opportunities were provided for parents to increase their skills as partners through math family nights and counselor led family nights. The district maintained opportunities for parents to participate in leadership roles including: School Site Council, Parent's Club, District English Language Advisory Committee, and LCAP Advisory committee.

Salida Union School District will receive \$6,514,034 LCFF Supplemental and Concentration funds based on the number and concentration of low income, foster youth and English learner students, which account for an estimated 75% Unduplicated Pupil Percentage. The district first considered the needs of foster youth, English learners, and low-income students in the planning of actions, services and programs. The justification for expending Supplemental and Concentration grant funds, which are principally directed toward unduplicated students, district-wide is to provide increased services to address academic, social-emotional, physical and mental health and the educational needs of Salida students and families. In addition, funds will provide professional learning related to specific actions and services to increase quality of educational achievement for Salida students. With an estimated three-fourths of our student population qualifying for additional funding, it is expected that all students will benefit from the actions supported by supplemental and concentration funds that provide professional learning related to specific actions and services to increase quality educational achievement for Salida students.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

After analyzing and evaluating the 2022-23 LCAP planned actions and services, educational partners identified high priority areas of service within the State and Local priority areas that will provide the most effective use of funds to meet goals for unduplicated pupils. Some of these high priority areas of services include instructional and classroom supplies; art and music instruction in both elementary and middle school grades; physical education across all grade levels; access to technology; S.T.E.A.M. instruction and activities; middle school elective offerings; campus safety and security; professional development to enhance high quality instruction; educational opportunities offered during the summer; supplemental services for English Learners; incentives for attendance; continued implementation of a multi-tiered system of support for engagement, academics, and behavior; and parent education, involvement and support.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

Due to the fact that every school in the district has a high concentration of unduplicated students (above 55%), the district increased staff at each school to provide direct services. Supplemental and Concentration funds cover employee salaries and benefits for additional student supports such as Instructional Teachers, Instructional Paraprofessionals, Counselors, Psychologist, Learning Center Assistants, Library Clerks, Cafeteria Monitors, Playground Aides, Campus Supervisors, and Computer Technicians.

The district focused its efforts to accelerate student learning through a multi-tiered system of academic and behavior support benefiting low-income, English learners and foster youth. Small group academic intervention focused on increasing English language proficiency and early literacy skills at elementary schools. Additional staff at each campus was added to increase access and provide direct services to district Tier 2 and 3 supports.

To address barriers to learning, the district focused on strengthening its Positive Behavior Intervention and Support (PBIS) structures. Counselors and district psychologists provided direct services to students with interventions and services for a variety of social and emotional concerns such as self-harm, anxiety depression and/or suicide threat. Counselors provided monthly newsletters to families giving tips, resources and strategies for health and coping (<https://www.stancoe.org/mental-health-resources>) as well as information to access district programs and services to support families. These direct services were provided to low-income, English learners and foster youth.

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action[s])

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
