CHARGE POLICY

An automated phone call will go home once per week as a reminder that your student's account has gone negative. You will continue to receive this automated reminder until the account is brought current. If you have submitted a Free or Reduced meal application, it may take up to 10 business days to process the application. **You are responsible for all charges incurred during this time, even if your application is eventually approved for Free or Reduced priced meals.**

Pre-Pay On-line
