## **II. DISCUSSION/INFORMATION AGENDA**

- A. Dale Scott and Company, Financial Advisors -- Salida Voter Survey Results
  - 1. Dale Scott presented the Voter Survey Results. This survey was conducted to determine if voters would support an additional measure for school bonds on the March or November ballot. The random survey of 152 likely voters was conducted between August 1, 2019 and August 5, 2019. 72% of voters surveyed stated that they would support a measure for school bonds. After reviewing the survey results, the Board agreed to move forward with the GO Bond preparation and place two measures on the March ballot. A resolution will be brought to the October board meeting to take action on placing the measures on the ballot.
- B. Quarterly Report on Williams Complaints, Subject Area of Complaints, and Resolution of Complaints
  - 1. Superintendent Tosh reported that there have been no complaints.

  - Superintendent informed the Board that Back to School Night would be taking place at the Elementary sites on Thursday, August 22, 2019 and at the Middle School on Thursday, August 29, 2019. She invited all Board Members to attend.
